### 2010 Highlights for the Township of Middlesex Centre

- The Township of Middlesex Centre's 2010 announced OMPF allocation totalled \$1,636,700.
- This exceeds the Township of Middlesex Centre's 2009 OMPF by \$11,800, and payments received under the previous program in 2004 by \$955,700.
- In addition, the Township of Middlesex Centre will receive a 2010 OMPF reconciliation payment of \$103,900 based on final 2010 OMPF cost data.

### 2010 OMPF Allocation Notice - Line Item Descriptions

<b>A</b>	Sum of the final 2010 reconciled OMPF grant components.
<b>A1 to A4</b>	The OMPF grants are described in detail in the OMPF Technical Guide – this document can be found on the Ministry of Finance's website at: <a href="http://www.fin.gov.on.ca/en/budget/ompf/2010/">http://www.fin.gov.on.ca/en/budget/ompf/2010/</a>
<b>B</b>	Transitional assistance ensures that the reconciled OMPF is maintained at the announced 2010 level.
<b>C1</b>	Sum of the announced 2010 OMPF grant components and transitional assistance.
<b>C2</b>	The amount of the final 2010 reconciliation payment that will be issued. Calculated as the amount by which Line A plus Line B exceeds Line C1.
<b>D</b>	Information regarding the announced 2010 Social Assistance Benefit Program Uploads for the County of Middlesex can be found on the enclosed 2010 Upload Notice Insert.
<b>E1</b>	The municipal benefit of the Province's 75% share of Public Health funding is relative to its 50% share in 2004. Actual municipal savings may not correspond with the Allocation Notice due to budget approvals made by the local Boards of Health. Municipalities may provide additional funding beyond their obligated cost share. This additional funding is not included in the calculation of the "Public Health Net Benefit".
<b>F1</b>	Refers to the costs that municipalities are responsible for under existing cost-sharing arrangements with the Province. Includes municipal costs for Ontario Works, Ontario Disability Support Program benefits, Child Care, Social Housing and the reinvestment of National Child Benefit Savings. Costs have been adjusted to reflect the phased uploads of Ontario Disability Support Program benefits and Ontario Works benefits.
<b>F3</b>	Refers to the total assessment for a municipality weighted by the tax ratio for each class of property (including payments in lieu of property taxes retained by the municipality) divided by the total number of households.
<b>F4</b>	Refers to the final 2010 eligible policing costs per household.
<b>F5</b>	Represents the proportion of a municipality's population that resides in rural areas or small communities.
