2010 Highlights for the Municipality of Temagami

- The Municipality of Temagami's 2010 announced combined benefit of OMPF and social assistance benefit program uploads totalled \$1,570,400 and included:
 - \$1,212,000 in funding through the OMPF, and
 - \$358,400 benefit from the provincial uploads
- This exceeds the Municipality of Temagami's 2009 combined benefit by \$89,600, and payments received under the previous program in 2004 by \$369,400.
- In addition, the Municipality of Temagami will receive a 2010 OMPF reconciliation payment of \$14,300 based on final 2010 OMPF cost data.

Municipalities may provide additional funding beyond their obligated cost share. This additional funding is not included in the calculation of the "Public Health Net Benefit". |
| F1 | Refers to the costs that municipalities are responsible for under existing cost-sharing arrangements with the Province. Includes municipal costs for Ontario Works, Ontario Disability Support Program benefits, Child Care, Social Housing and the reinvestment of National Child Benefit Savings. Costs have been adjusted to reflect the phased uploads of Ontario Disability Support Program benefits and Ontario Works benefits. |
| F3 | Refers to the total assessment for a municipality weighted by the tax ratio for each class of property (including payments in lieu of property taxes retained by the municipality) divided by the total number of households. |
| F4 | Refers to the final 2010 eligible policing costs per household. |
| F5 | Represents the proportion of a municipality's population that resides in rural areas or small communities. |
| F6 | Refers to the total household income for all residents of the municipality. |
