2014 Highlights for the Municipality of Central Elgin

- The Municipality of Central Elgin's combined benefit of the 2014 OMPF and provincial uploads totals \$585,000 which is the equivalent of 5% of the Municipality's municipal property tax revenue.
- The Municipality's combined benefit includes:
 - \$567,100 through the OMPF
 - \$17,900 benefit resulting from the provincial uploads
- The estimated total benefit of the 2014 provincial uploads for the County of Elgin is \$3,537,700 which is the equivalent of 6% of all municipal property tax revenue in the County.

The estimated total benefit of the 2014 provincial uploads for the County of Elgin is \$3,537,700.

2014 OMPF Allocation Notice - Line Item Descriptions

- A5** If applicable, reflects the amount of transitional support provided to assist the municipality in adjusting to the redesigned OMPF program.

- B1** Sum of 2014 OMPF grants. (Equal to Line A)

- B2** Estimated funding provided to the municipality by the Ministry of Community Safety and Correctional Services with respect to the Province's phased upload of court security and prisoner transportation costs in 2014.
-
- C1** The estimated 2014 municipal benefit of the Province's 75 per cent share of public health funding relative to its 50 per cent share in 2004. Actual municipal savings may not correspond with the Allocation Notice due to budget approvals made by the local Boards of Health. Municipalities may provide additional funding beyond their obligated cost share. Any additional municipal funding is not included in the calculation of the public health figure.

- C2** The estimated 2014 municipal benefit of the Province's 50 per cent share of land ambulance funding is relative to its share in 2005. This incremental increase in land ambulance funding delivers on the Province's commitment to strengthen land ambulance services and maintain the 50:50 sharing of land ambulance costs.

- D2** Refers to the total assessment for a municipality weighted by the tax ratio for each class of property (including payments in lieu of property taxes retained by the municipality) divided by the total number of households.

- D3** Represents the proportion of a municipality's population that resides in rural areas or small communities. For additional information see the 2014 OMPF Technical Guide.
-
- D4** The northern and rural Municipal Fiscal Circumstances Index (MFCI) measures a municipality's fiscal circumstances relative to other northern and rural municipalities in the province, and ranges from 0 to 10. A lower MFCI corresponds to relatively positive fiscal circumstances, whereas a higher MFCI corresponds to more challenging fiscal circumstances. - D5** Represents the guaranteed level of support the municipality will receive from the Province through the 2014 OMPF. For additional information see the 2014 OMPF Technical Guide.
